Special and/or sensitive personal data that we process

- Très Chic Bridal wear also processes personal data if we are legally required to do so, such as information that we required for our tax return.

Très Chic Bridal wear will not retain your personal data for longer than is strictly necessary to achieve the goals for which your data is collected.

Sharing of personal data with third parties

Très Chic Bridal wear will not sell your data to third parties and will only provide this information if required for the implementation of our agreement with you or to fulfil a legal obligation. Cookies or comparable technologies that we use

Très Chic Bridal wear uses functional, analytical and tracking cookies. A cookie is a small text file that is saved in the browser of your computer, tablet or smartphone during your first visit to this website. Très Chic Bridal wear uses cookies with a purely technical functionality. These cookies enable the website to work properly and ensure, for example, your preferred settings are remembered. These cookies are also used to enable the website to function properly and to be able to optimise the site. Viewing, changing or deleting data

photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and social security number. This is to protect your privacy.
